Supplementary Regulations:

1. **JURISDICTION** – Held under the National Sporting Code of the ACU, the standard enduro regulations of the ACU and these Southern Motor Cycle Club Supplementary regulations. And any final instructions issued.
2. **ELIGIBILITY** – Open to all adult members (over 16 yrs old) holding ACU Licenses and those with a day license riding solo machines. Parental Consent forms will be required for riders under the age of 18 years of age. One event licenses (£15) will be available if a rider does not hold a valid competition license. Where the Enduro includes the use of public highways, then it is the sole responsibility of the rider to ensure that his machine is roadworthy and that he and his machine comply with all legal requirements.
3. **ENTRIES – IN ADVANCE ONLY**, either at **TYNWALD PUB, ST JOHNS** on Wednesday 9th January or by post. Entry fee £25.00. Cheques payable to S.M.C.C Ltd. Closing date for **ALL** entries: Wednesday 9th January. If you require a day license, please enter at the TYNWALD as no paperwork can be done on the day.
4. **MEMBERSHIP**- All entrants must show their club membership card when signing on. Non-members are required to complete the attached Membership form, annual membership £15.00. One event membership will be available to non-members £5.00
5. **CLASSES** – All classes are 2T/4T. Experts, Clubman & Sportsman.
6. **REGISTRATION ON THE DAY** – All classes 8.45am at Dalby Mountain.
7. **EVENT DETAILS: TIME CARD ENDURO** starts 9.30am at Dalby Mountain, and will include special tests at Cringle & Dalby Mountain. The course will use tracks, plantations and private land. There are no closed roads in this event, please be alert for walkers, horses, cyclists and other road users. Please **CLOSE GATES** afterwards. The route will be given out on the day at signing on. **ALL RIDERS ARE REMINDED NOT TO RACE ON THE ROADS.**
8. **INSURANCE** – Each rider will be required to declare that there will be insurance in force in relation to the use of the machine which he intends to drive during the event, such a policy of insurance or such a security in respect of Third Party risks, as complies with the requirements of the Road Traffic Acts, and which is operative whilst taking part in the event. (ESR31) **Cover is available at Signing On.**
9. **TYRES** – Front & Rear **MUST** be Enduro type to current ACU/FIM specification (ESR 8) **ABSOLUTELY NO MOTORCROSS TYRES.**
10. **FIRE EXTINGUISHER** - All riders **MUST** have a 2kg Dry Powder fire extinguisher. (ESR37)
11. **RIDER'S NUMBER** – Please use SMCC Enduro Numbers for this event. New riders can request a number via the website. Riders must provide their own numbers as per ACU Technical specifications, and may we request that a coloured background is used to assist with timekeeping.
12. **AWARDS** – Points will be awarded as per the SMCC Enduro points system to count in the championship.
13. **PRACTICING** - Practicing on part of the course is forbidden, Special tests may be inspected on foot but NOT by any wheeled vehicle (including mountain bikes) and breach of this rule will render the competitor liable to exclusion.
